Federal-Mogul Sevierville, LLC (Tenneco) has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development. Employees will be permanently laid off, with the first round of 60-day notices provided to employees on 10/3/2024. Layoffs will continue into the early months of 2025. The company is located at 128 River Bend Dr., Sevierville, TN 37876. The total number of affected workers is 242. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on October 2, 2024.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The East Local Workforce Development Board's rapid response team, employed by the East Tennessee Human Resources Agency, has been notified to coordinate services with the employer and

affected employees. The East Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
