Detailed Census 2010 Data

Starting with the first U.S. Census in 1790, the primary goal is obtaining current population totals of inhabitants at their “usual residence” to be used for Congressional apportionments. Usual residence has been defined as the place where a person lives and sleeps most of the time (i.e. homes, college dorms, prisons) without regard for legal status or citizenship. Foreign nationals temporarily traveling or visiting the United States are excluded from the count.

Americans who are temporarily overseas are to be enumerated at their usual U.S. residence. Military personnel and federal civilian employees stationed outside the United States and their dependents are to be included in the population counts for Congressional apportionment but excluded from other tabulations of state and sub-state areas.

Once the population totals are complete, the information is available for the purposes of reapportioning Congressional seats. The second set of releases, released in groups of states, is some detailed demographic information. The population, age distribution, race, and household totals were released in August for Tennessee. A small sample of this data,

for the counties with populations greater than 100,000, is shown on Page 2.

Population Data

The Census 2010 population in Tennessee is 6,346,105. This is an increase of 656,822 from the Census 2000 count. The largest counties are Shelby (927,644, up 30,172 persons), Davidson (626,681, up 56,790 persons), Knox (432,226, up 50,194 persons), Hamilton (336,463, up 28,567 persons), and Rutherford (262,604, up 80,581 persons). Of the 12 counties studied, Rutherford had the largest increase in population, while Sullivan (up 3,775 persons) had the smallest. Not surprisingly, Sullivan went from the sixth most populous county to the ninth, switching places with Williamson during the last 10 years.

These 12 counties account for 57 percent of the state’s total population but account for 65.8 percent of the population growth during that time (an increase of 432,534 of the total 656,822). Williamson County had the highest percentage of minors in the population (29.3 percent), while Sullivan County had the highest percentage of seniors (22.7 percent). Every county had more

women than men, and Shelby County had the highest percentage of females (52.3).

Race Identification

The concept of race, as used by the Census Bureau, reflects self-identification by people according to the race or races with which they most closely identify. These categories are socio-political constructs and should not be interpreted as being scientific or anthropological in nature. The race categories include both racial and national origin groups.

Persons may have chosen two or more races either by checking two or more race response boxes or by multiple write-in responses. People who identify their origin as Hispanic or Latino may be of any race.

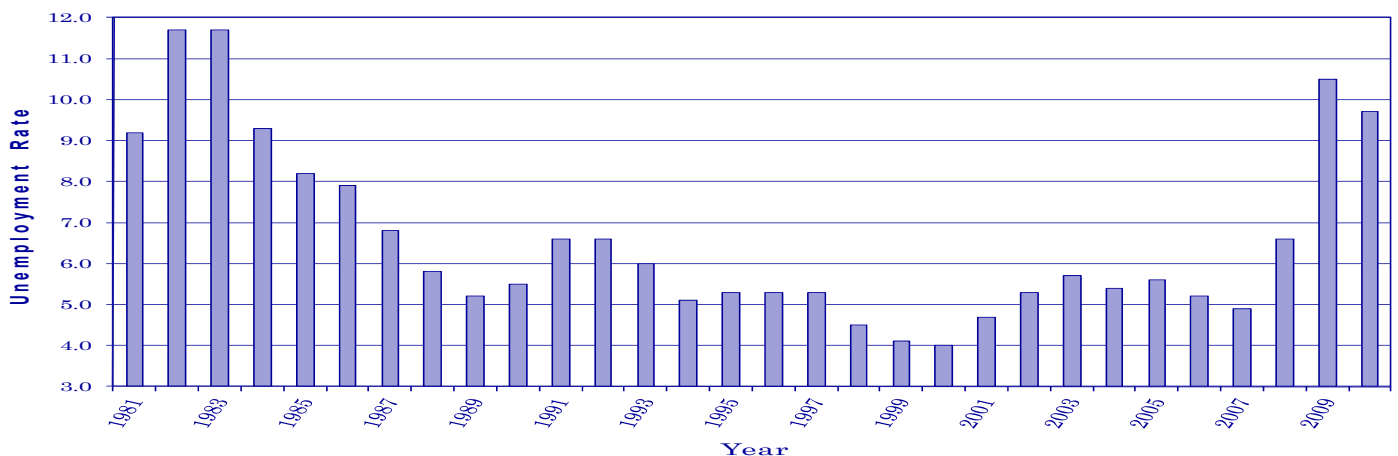

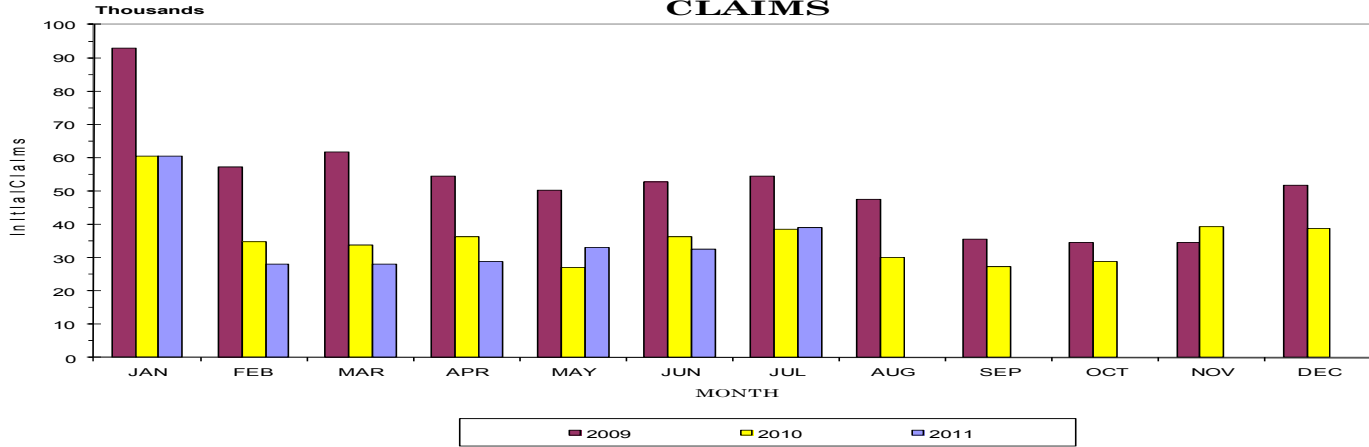
Unemployment Rates 1981-2010

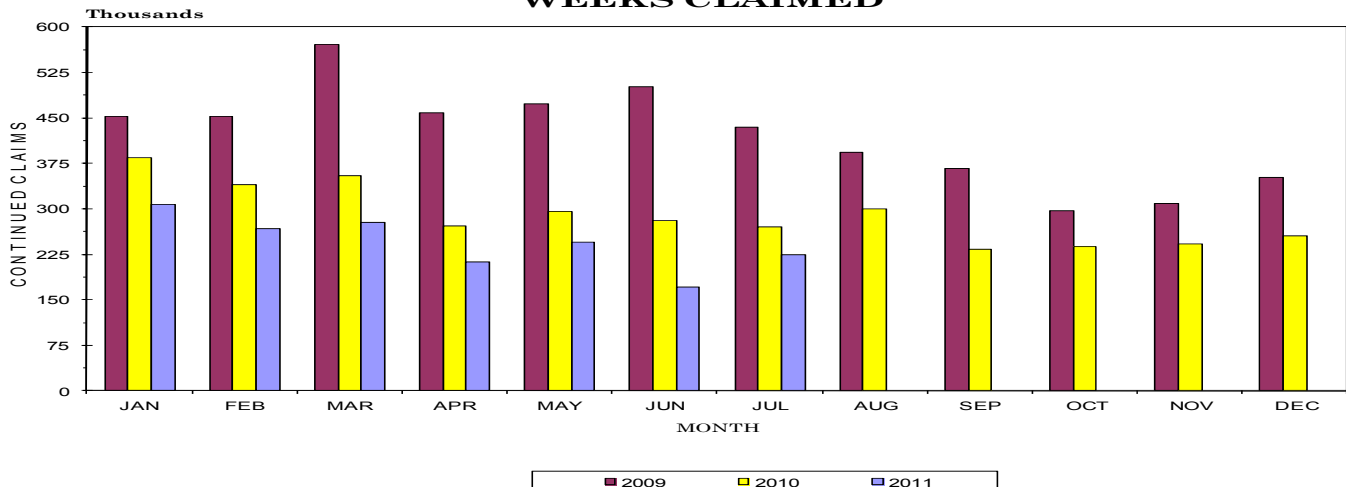

NONFARM EMPLOYMENT AND LABOR FORCE IN TENNESSEE

Total nonfarm employment increased by 19,300 jobs from August 2010 to August 2011. This includes increases in professional/business services (up 11,200 jobs), which includes increases of 7,000 jobs in administrative/support/waste management and 2,900 jobs in professional/scientific/technical services; mining/logging/construction (up 5,900 jobs); health care/social assistance (up 4,500 jobs), which includes increases of 3,100 jobs in nursing/residential care facilities and 1,700 jobs in ambulatory health care services; food services/drinking places (up 4,200 jobs); transportation/warehousing and transportation equipment manufacturing (both up 3,100 jobs); and durable goods wholesalers and financial activities (both up 1,600 jobs). This was partially offset by decreases in retail trade (down 6,100 jobs), which includes a drop of 1,500 jobs in gasoline stations and 1,300 jobs in general merchandise stores; local government (down 3,400 jobs); federal government (down 3,000 jobs); state government educational services (down 1,100 jobs); and nonmetallic mineral products (down 1,000 jobs).

During August, nonfarm employment increased by 18,100 jobs. This included seasonal increases in local government (up 13,600 jobs), which includes an increase of 11,400 jobs in local government educational services; administrative/support/waste services (up 6,300 jobs); educational/health services (up 2,200 jobs), which includes an increase of 1,200 jobs in health care/social assistance; and mining/logging/construction (up 1,400 jobs). This was offset by a plant closing in plastics/rubber products (down 1,900 jobs); leisure/hospitality (down 1,800 jobs), which includes a drop of 1,300 jobs in arts/entertainment/recreation; and wholesale trade (down 1,000 jobs).

Tennessee's seasonally adjusted estimated unemployment rate for August 2011 was 9.7 percent, down 0.1 percent from the revised July 2011 rate.

The United States' unemployment rate was 9.1 percent in August 2011. In August 2010, the national unemployment rate was 9.6 percent, and the state's unemployment rate was 9.4 percent.

Across Tennessee, the unemployment rate decreased in 57 counties, increased in 28 counties, and remained the same in 10 counties. There were 34 counties with an unemployment rate less than 10 percent, and three counties had a rate at or above 15 percent. In June, the lowest rate occurred in Lincoln County at 6.4 percent, up 0.2 percent from the previous month. The highest rate was Scott County's 19.7 percent, down from 19.8 percent in July 2011.

Over the past 12 months, Obion County had the greatest increase in its unemployment rate (up 7.6 percent, of which 5.8 percent occurred in July 2011). There were 880 new unemployed persons during last month. This was due to the closure of a large manufacturing company in that county.

The data from all the nonfarm employment estimates tables include all full- and part-time nonfarm wage and salary employees who worked during or received pay for any part of the pay period that includes the 12th of the month. This is a count of jobs by place of work. Agricultural workers, proprietors, self-employed persons, workers in private households, and unpaid family workers are excluded. These numbers may not add due to rounding. Data is based on the 2010 benchmark.

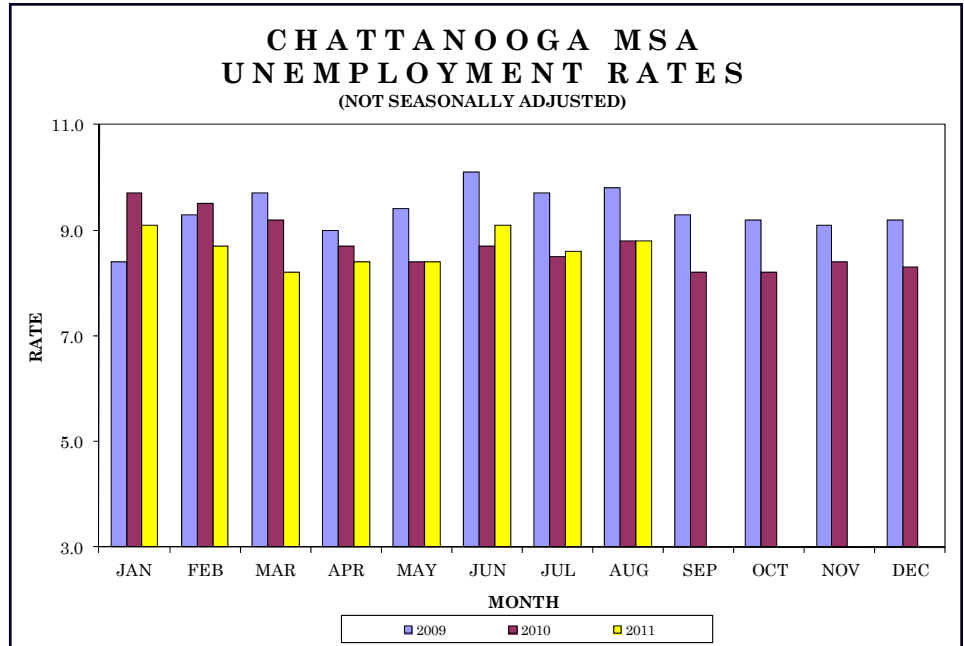

Total nonfarm employment increased by 100 jobs from July 2011 to August 2011. There were seasonal increases in professional/business services (up 700 jobs), local government (up 300 jobs), and educational/health services (up 200 jobs). This was partially offset by declines in leisure/hospitality (down 400 jobs), retail trade (down 300 jobs), and nondurable goods manufacturing (down 200 jobs).

During the past 12 months, nonfarm employment increased by 2,500 jobs. During that time, goods-producing jobs decreased by 100, while service-providing jobs increased by 2,600.

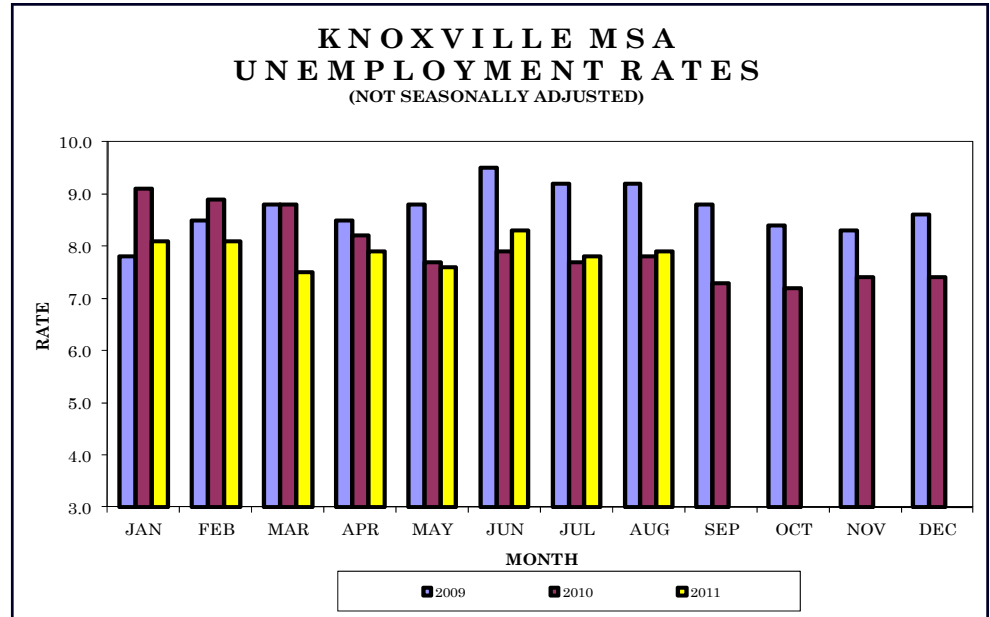

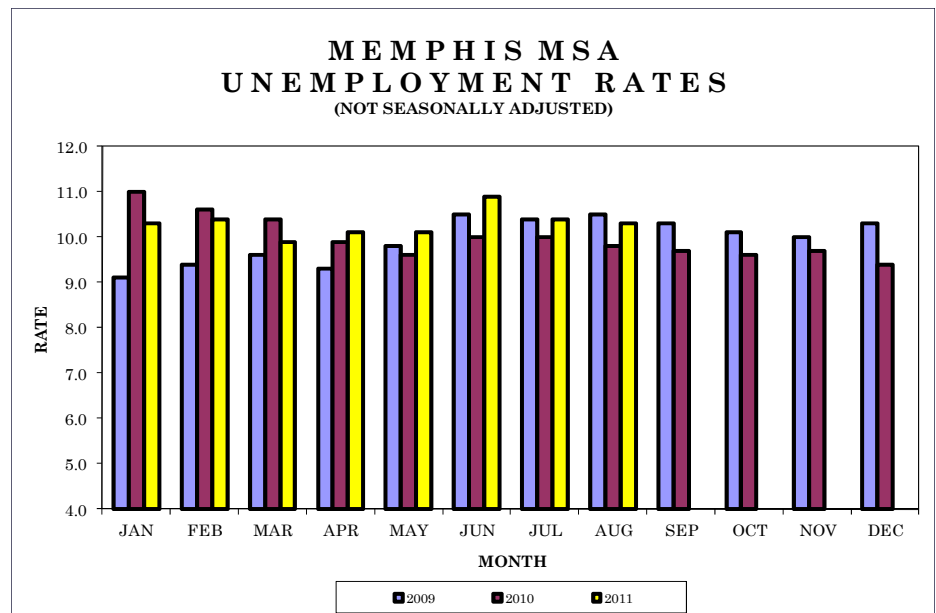

Total nonfarm employment increased by 4,900 jobs from July 2011 to August 2011. There were seasonal increases in local government (up 3,300 jobs), educational/health services (up 2,100 jobs), administrative/support/waste management (up 1,400 jobs), mining/logging/construction and financial activities (both up 500 jobs), wholesale trade (up 400 jobs), and durable goods manufacturing (up 200 jobs). This was partially offset by seasonal declines in leisure/hospitality and retail trade (both down 1,300 jobs), and professional/scientific/technical services and federal government (both down 300 jobs).

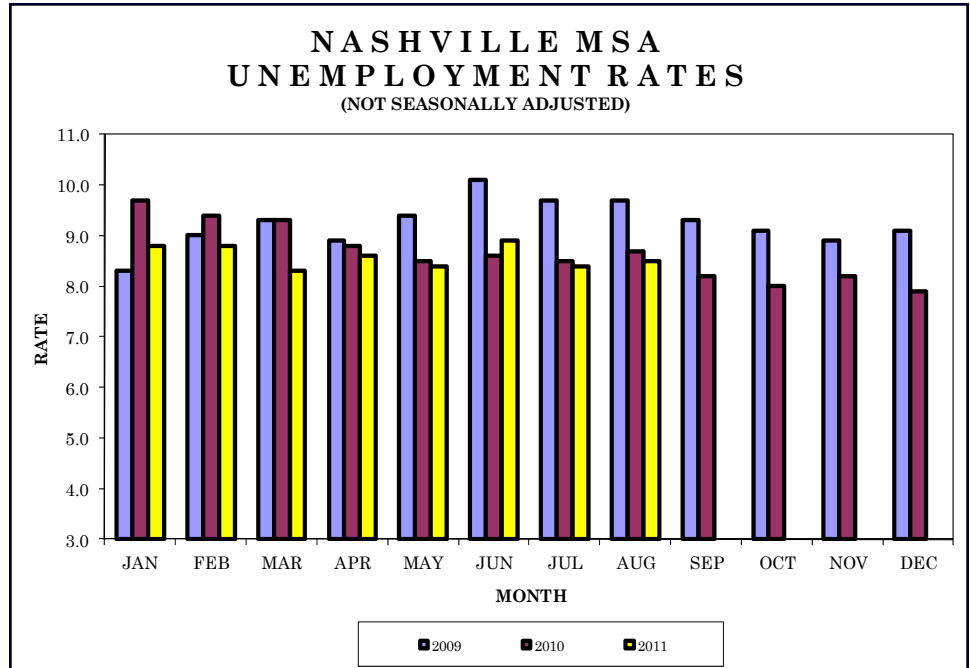

Total nonfarm employment increased by 8,500 jobs from July 2011 to August 2011. There were seasonal increases in local government (up 5,400 jobs); professional/business services (up 2,200 jobs), which includes an increase of 1,600 jobs in administrative/support/waste management and 500 jobs in professional/scientific/technical services; mining/logging/construction (up 900 jobs); and retail trade, financial activities, and other services (each up 400 jobs). This was partially offset by decreases in wholesale trade (down 500 jobs), durable goods manufacturing (down 400 jobs), and health care/social assistance (down 200 jobs).

During the past 12 months, nonfarm employment increased by 11,900 jobs. During that time, goods-producing jobs increased by 1,200, while service-providing jobs increased by 10,700.

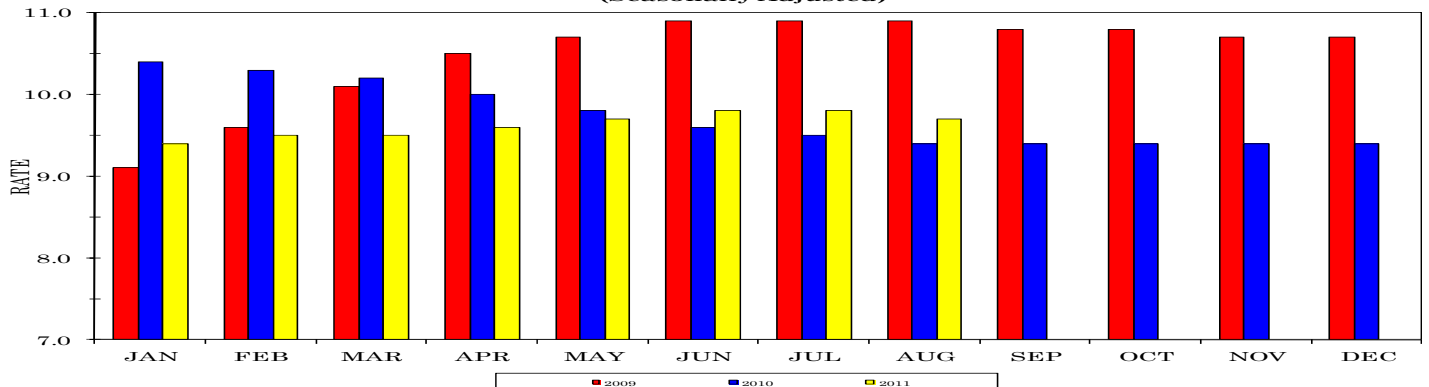
