According to estimates published by the Bureau of the Census, the 2007 population of Tennessee was 6,156,719, up 81,806 (1.35 percent) from the previous July 1 estimate. (See the table on Page 2.)

The Population Division of the Census Bureau produces estimates of state and county populations each July 1. The methodology has remained unchanged for over two decades.

The most recent decennial census data from April 1, 2000, were used. The updated population estimates include births, deaths, internal migration, and international migration that have occurred from the census date to the date of the population estimate. For the net migration component, the bureau relies on the annual extract of tax returns to develop net migration rates for the population under age 65 for each county.

The largest county population increases in the past year were in Rutherford County (up 10,482), Knox County

(up 7,522), Williamson County (up 7,034), Montgomery County (up 6,443), Davidson County (up 5,770), Sumner County (up 4,187), and Wilson County (up 3,150). These seven counties had a total population increase of 44,588, or 54.5 percent, of the entire state increase.

During the past year, Rutherford County had the largest percentage increase (up 4.54 percent), followed by Williamson County (up 4.42 percent), Montgomery County (up 4.35 percent), and Fayette County (up 3.97 percent). Shelby County had the largest population decrease, declining by 505 persons from last year (down 0.06 percent). The largest percentage decline was the 1.12 percent drop in Clay County.

Since the 2000 Census, the largest growth counties were Rutherford County (up 59,439 persons), Davidson County (up 49,735 persons), Knox County (up 41,842 persons), and Williamson County (up 39,490 persons). The largest percentage increases were in Rutherford County (up 32.65 percent), Williamson

County (up 31.18 percent), Fayette County (up 29.12 percent), Wilson County (up 19.76 percent), and Sequatchie County (up 17.58 percent). Weakley County declined by 1,668, while Lake County dropped by 6.83 percent.

Weakley and Obion counties had population declines for seven consecutive years. Last year, 12 of the 95 counties saw population declines. Six of those declining counties are in West Tennessee, while there were three each in the other grand divisions of the state. The 10 highest growth counties were urban or suburban areas.

There are five counties with a population greater than 200,000. They are Shelby (910,100), Davidson (619,626), Knox (423,874), Hamilton (330,168), and Rutherford (241,462). There are seven counties with populations greater than 100,000 but less than 200,000. The smallest counties are Pickett (4,762), Van Buren (5,437), and Moore (6,119).

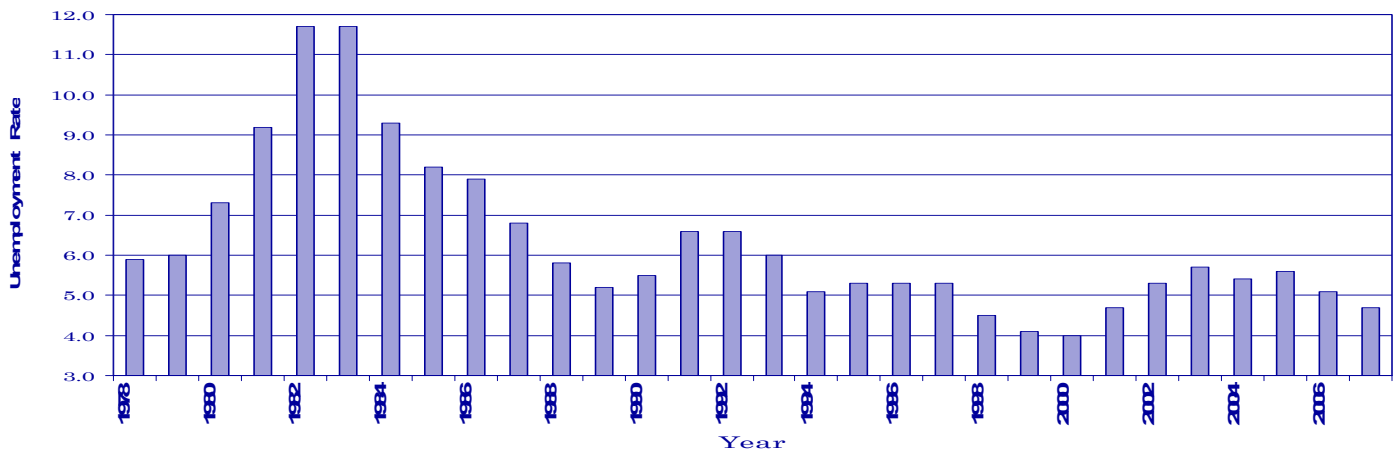

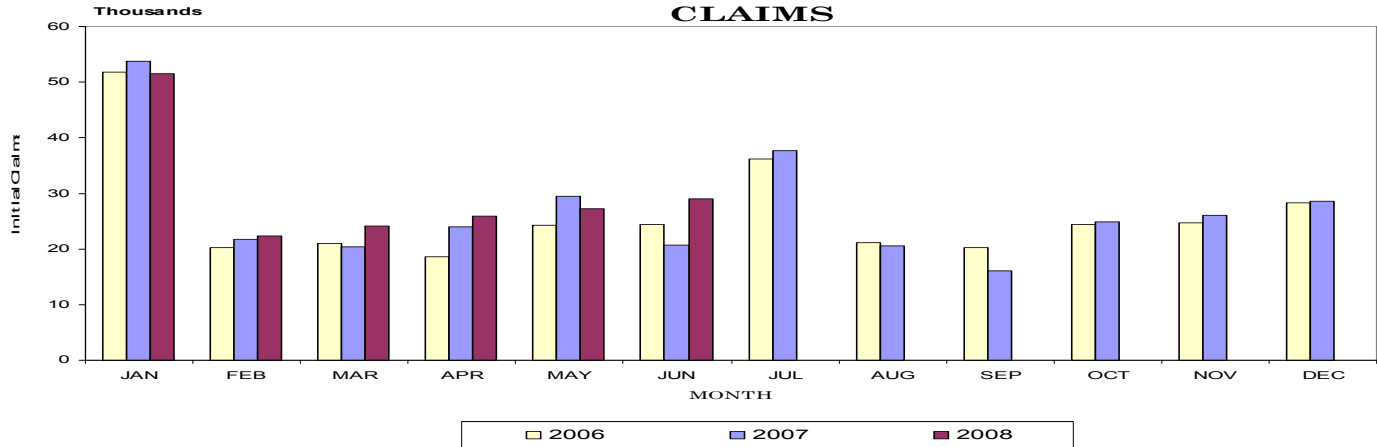
## Unemployment Rates 1978-2007

### MONTHLY INITIAL CLAIMS



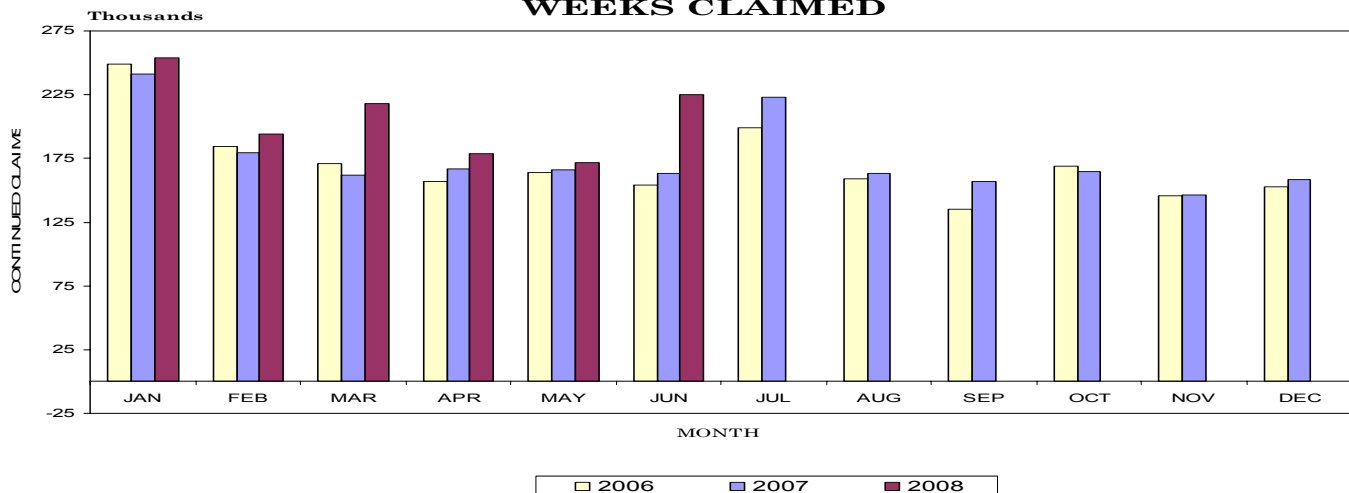

## NONFARM EMPLOYMENT AND LABOR FORCE IN TENNESSEE

Total nonfarm employment decreased by 13,300 jobs from July 2007 to July 2008. During this period, there were decreases in professional/business services (down 5,100 jobs), which includes drops of 2,800 jobs in professional/scientific/technical services and 2,700 jobs in administrative/support/ waste management; financial activities (down 3,400 jobs), which includes decreases of 1,900 jobs in finance/insurance and 1,500 jobs in real estate/rental/leasing; leisure/hospitality (down 2,800 jobs), which includes a decrease of 2,100 jobs in arts/entertainment/ recreation: furniture/related product manufacturing (down 1,900 jobs); wood product manufacturing (down 1,800 jobs); other services (down 1,500 jobs); and truck transportation (down 1,200 jobs). This was partially offset by increases in health care/ social assistance (up 5,300 jobs), which includes an increase of 2,700 jobs in hospitals and 2,300 in ambulatory health care; local government educational services (up 2,900 jobs); general merchandise stores (up 1,700 jobs); and educational services (up 1,200 jobs).

During this month, nonfarm employment decreased by 16,000 jobs. The largest seasonal declines were in local government educational services (down 3,700 jobs); transportation equipment manufacturing (down 2,000 jobs); state government educational services (down 1,600 jobs); professional/business services (down 1,300 jobs), which includes a drop of 1,000 jobs in professional/scientific/technical services; and truck transportation and other services (both down 1,100 jobs).

Tennessee's seasonally adjusted estimated unemployment rate for July 2008 was 6.9 percent, up 0.4 percent from the June rate. After benchmark adjustments, this is the 12th consecutive month that the current rate is greater than or equal to the national average.

The United States' unemployment rate was 5.7 percent in July 2008. In July 2007, the national unemployment rate was 4.7 percent, and the state's unemployment rate was 4.6 percent.

Across Tennessee, the unemployment rate increased in 60 counties, decreased in 29 counties, and remained the same in six counties. There were 15 counties with an unemployment rate of 10 percent or greater. The lowest rate occurred in Williamson County at 4.6 percent, down 0.2 percent from the previous month. The highest rate was Perry County's 20.3 percent, up from 14.8 percent in June 2008.

The data from all the nonfarm employment estimates tables include all full- and part-time nonfarm wage and salary employees who worked during or received pay for any part of the pay period that includes the 12th of the month. This is a count of jobs by place of work. Agricultural workers, proprietors, self-employed persons, workers in private households, and unpaid family workers are excluded. These numbers may not add due to rounding. Data is based on the 2007 benchmark.

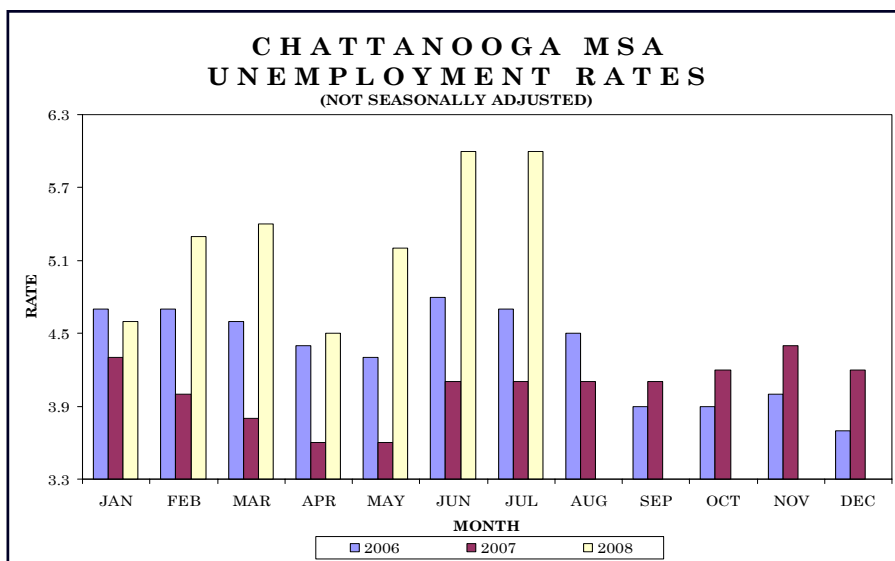

Total nonfarm employment decreased by 100 jobs from June 2008 to July 2008. There were small increases and decreases across the entire spectrum of the Chattanooga economy as well as a seasonal decline in mining/construction (down 200 jobs).

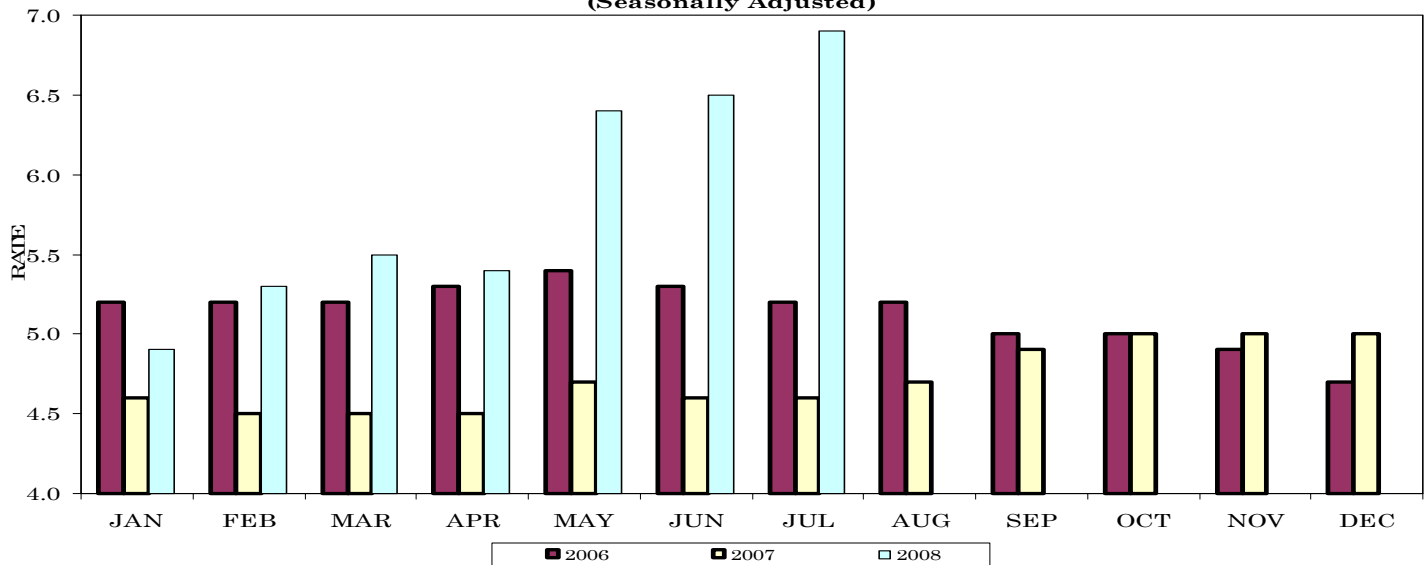

## IMPORTANT CHANGES IN 2008

Every year there are slight differences to the tables of information. Most of these modifications are due to the size of the industry reporting and the confidentiality restraints. This year there are many more changes than normal to the Labor Market Report. Most of these adjustments are due to funding cuts in federally supported programs. This includes the elimination of all 'hours and earnings' data in the metro areas. That has changed the layout of this publication. The changes are explained below.

**Page 5:** The entire narrative that previously began on Page 5 and continued on Page 6 is now on Page 5.

**Page 6:** The statewide hours and earnings of manufacturing production workers, previously shown on Page 5, are gradually being phased out by BLS. Statewide hours and earnings at the total and subtotal levels remain and are now published on Page 6. There is a new series of hours and earnings for all employees. This is the bottom of Page 6. The All Employee Hours and Earnings is lagged by one month due to the inaugural release date of February 2008.

Six of the micropolitan areas that were on this page have been moved to the MSA pages. These micro areas are not part of the MSA definitions, but they fall geographically within the metro counties.

**Pages 7 thru 10** are the metropolitan areas and each has a similar change. All the hours and earnings of manufacturing production workers for the metro areas have been eliminated due to budget cuts. Replacing this information is LAUS data for smaller communities within the metro areas. This includes cities of greater than 25,000 population, as defined by BLS, and the micropolitan areas explained in the prior paragraph. The monthly labor force and unemployment will be available. This will give a better picture of the economic health of the MSA area.

**Page 11:** This data will look the same as in prior years, but there is a slight difference. The Cleveland and Morristown metro areas have been eliminated by BLS. The states had the option of collecting and reporting this data with state funding. Tennessee chose to keep collecting this data. There is hope that this funding will be restored in FY 2009.
