APL Logistics, Ltd. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure on April 30, 2024. The company is located at 501 Darrell Waltrip Dr., Lebanon, Tennessee 37090. The total number of affected workers is 52. The facility will permanently close on April 30, 2024. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on February 7, 2024.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected

employees. The Northern Middle Local Workforce Development area will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
