Aspiration Partners, Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff. The layoffs will occur between June 30, 2023, and September 30, 2023. This company is headquartered at 4551 Glencoe Ave., Suite 300, Marina Del Rey, California 90292; however, some remote workers are in Davidson County, Tennessee. The total number of affected workers in Tennessee is 5. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 26, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle, Local Workforce Development Board, will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
