Beiersdorf Manufacturing LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff beginning January 31, 2023, with all separations expected to be complete on or around April 1, 2023. The total number of affected workers is 140. This company is located at 4207 Michigan Avenue Road, NE, Cleveland, TN 37323. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on November 30, 2022.

The employees at the facility are not represented by a collective bargaining agreement. The Southeast Local Workforce Development Area rapid response team, employed by Southeast TN Development District, has been notified to coordinate services with the employer and affected employees. The Southeast Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
