CHEP Services, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure on August 5, 2024. The company is located at 1540 Amherst Road, Knoxville, Tennessee 37909. The total number of affected workers is 58 Tennessee employees. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 31, 2024.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The East Local Workforce Development Rapid Response team, employed by the East Tennessee Human Resources Agency, has been notified to coordinate services with the employer and

affected employees. The East Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
