Cargill Meat Solutions Corporation has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a partial permanent layoff on March 15, 2024. The total number of affected workers is 111. This layoff will only affect its "crumbles production" at Cargill Meat Solutions located at 2621 Eugenia Ave., Nashville, TN 37211. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on January 24, 2024.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the Mid-Cumberland Human Resource Agency, has been notified to coordinate services with the employer and affected employees. Mid-Cumberland Human Resource Agency will be responsible for the oversight of the continued follow-up of
