Chugach Federal Solutions, Inc (CFSI) has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff on June 30, 2024. The company is located at 1478 Fifth Street, Arnold Air Force Base, TN 37389. The total number of affected workers is approximately 260. A new contractor will replace the current operating contractor at Arnold AFB. The company stated, "While we do not have insight to how many of our incumbent workforce will be offered employment with the successor contractor, we do believe a large majority of our employees will be offered a position to continue to work at Arnold AFB." The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 2, 2024.

Some of the employees at the facility are represented by a collective bargaining agreement but do not have bumping rights due to the contract ending. The Southern Middle Areas Rapid Response Team, employed by the South Central TN Development District, has been notified to coordinate services with the employer and affected employees. The Southern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
