Cygnus Home Services, LLC d/b/a Yelloh has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure effective December 15, 2023. The total number of affected workers is 23. This company is located at 153 Roscoe Fitz Road, Gray, TN 37615, 43 Truck Center Drive, Jackson, TN 38305, and 105 Mundy Memorial Drive, Mt. Juliet, TN 37122. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on October 26, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Northeast, Northern Middle, and Southwest Local Workforce Development Area rapid response team, employed by the First TN Development District, Workforce Essentials, and Workforce Innovations Inc., has been notified to coordinate services with the employer and affected employees. The Northeast, Northern Middle, and Southwest Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
