David's Bridal LLC filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure to take place on or around June 12, 2023, through August 11, 2023. The total number of affected workers in Tennessee is 206. At this time, David's Bridal expects the only employees that will be affected to be at their headquarters in Pennsylvania. This company has locations in Tennessee at the following locations 1728 Galleria Boulevard, Suite 101, Franklin, TN 37607; 2765 Wolf Creek Parkway, Suite 101, Memphis, TN 38133; 7900 Kingston Pike, Knoxville, TN 37919; 321 Gallatin Pike, North, Madison, TN 37115; 1820 Gunbarrel Road Ste., 400, Chattanooga, TN 37421; 3135 Peoples Street Ste., 100, Johnson City, TN 37604; and 2615 Medical Center Pkwy, Ste. 450, Murfreesboro, TN 37129. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 14, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle, Greater Memphis, East, Southeast, and Northeast Local Workforce Development Area rapid response teams, employed by Workforce Essentials, Workforce Midsouth, East TN HRA, First TN Development District, and Southeast TN Development District, have been notified to coordinate services with the employer and affected employees. The Northern Middle, Greater Memphis, East, Southeast, and

Northeast Local Workforce Development Board, will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
