FedEx Supply Chain, Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure with layoffs starting April 4th, 2022, and finalizing May 31st, 2022. The total number of affected workers is 65. This company is located at 101 Veterans Drive, Portland, TN 37148. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on February 7th, 2022.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce

Essentials; has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
