GH Armor Systems ("Safariland") has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff to begin on February 20, 2024, with subsequent separations anticipated to occur through June 30, 2024. The total number of affected workers is 40. This company is located at 1 Sentry Drive, Dover, TN 37058. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on January 2, 2024,

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid
