Ingram Entertainment Inc. WARN # 202400014

Ingram Entertainment Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff. The layoffs are expected between November 13, 2023, and December 29, 2023. The total number of affected workers is 63. This company is located at Two Ingram Blvd., La Vergne, TN 37089. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on October 5, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
