JCF Housements Manufacturing, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff on May 17, 2023. The total number of affected workers is 79. This company is located at 63 East Park Drive, Fayetteville, TN 37334. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 19, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Southern Middle Local Workforce Development Area rapid response team, employed by the South-Central TN

Development District, has been notified to coordinate services with the employer and affected employees. The Southern Middle, Local Workforce Development Board, will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
