LGSTX Cargo Services, Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure on June 18, 2024. The company is located at 381 Air Freight Boulevard, Nashville, TN 37217. The total number of affected workers is 97. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 17, 2024.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The Northern Middle rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid
