SUBJECT: Employee Dislocation Notification Lyft Inc. WARN # 202300019

Lyft Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff effective April 28, 2023. According to the company's notice, 'Affected employees are receiving pay and benefits in lieu of 60 days' notice.' The total number of affected workers is 133. This company is located at 150 2nd Ave N, 4th floor, Nashville, TN 37201. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 27, 2023. The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle, Local Workforce Development Board, will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
