Maximus, Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff on July 31, 2024. The company is located at 1600 Tysons Blvd, McLean, VA 22102; affected employees are located at 3915 S Mendenhall Road, Memphis, TN 38115. The total number of affected workers is 140. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 24, 2024.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The Greater Memphis Rapid Response team, employed by the Greater Memphis Chamber, has been notified to coordinate services with the employer and affected employees. The Greater Memphis
