McMinnville Manufacturing, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure on April 18, 2024, with all separations complete by May 17, 2024. The company is located at 215 South Chancery Street, McMinnville, TN 37110. The total number of affected workers is 45. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 24, 2024.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The Upper Cumberland rapid response team, employed by the Upper Cumberland Local

and Workforce Development Board, has been notified to coordinate services with the employer and affected employees. The Upper Cumberland Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
