Morgan Olson, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff. Employee separations will begin on December 22, 2023, and are expected to be complete by the end of 2023. The total number of affected workers is 290. This company is located at 9600 Corporate Park Dr., Loudon, TN 37774. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on October 24, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The East Local Workforce Development Area rapid response team, employed by East Tennessee HRA, has been notified to coordinate services with the employer and affected employees. The East Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
