Nyrstar Tennessee Mines - Gordonsville LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff. Employee separation begins on December 31, 2023, and is expected to last for an unknown period. The total number of affected workers is 300. This company is located at 120 Zinc Mine Circle, Gordonsville, TN 38563. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on October 30, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Upper Cumberland Local Workforce Development Area rapid response team, employed by the Upper Cumberland LWDB, has been notified to coordinate services with the employer and affected employees. The Upper Cumberland Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
