Packers Sanitation Services, Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff on July 11, 2023. The total number of affected workers is 71. This layoff is the result of a contract cessation. This company is located at 201 Cartwright Street, Goodlettsville, TN 37072. All employees at this location will be offered a job transfer to another PSSI plant in the area. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 26, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials, has been notified to coordinate services with the employer and affected employees. The Northern Middle, Local Workforce Development Board, will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
