Ryder Integrated Logistics, Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure. Job losses are expected to begin June 16, 2024, with a final closure on June 30, 2024. The company is located at 90 Deer Crossing Road, Vonore, TN 37885. The total number of affected workers is 80. The facility will permanently close on June 30, 2024. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on February 7, 2024.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The East Local Workforce Development Area rapid response team, employed by the East

Tennessee Human Resource Agency, has been notified to coordinate services with the employer and affected employees. The East Local Workforce Development area will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
