Tsiyahi, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff. Employee separation began on November 23, 2023, and is expected to be complete by December 20, 2023; all employees are expected to return to work by March 11, 2024. The total number of affected workers is 10. This company is located at 10035 Campground Drive, Townsend, TN 37882. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on November 30, 2023.

The employees at the facility are not represented by a collective bargaining agreement. The East Local Workforce Development Area rapid response team, employed by the East Tennessee Human Resource

Agency, has been notified to coordinate services with the employer and affected employees. The East Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
