Unipower, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure on June 30, 2024. The company is located at 65 Industrial Park Rd., Dunlap, TN 37327. The total number of affected workers is 29. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 17, 2024.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The Southeast Rapid Response team, employed by the Southeast Tennessee Development District, has been notified to coordinate services with the employer and affected employees. The Southeast
