ABM Industry Groups, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective December 31, 2020. The total number of affected workers is 87. The cause of this layoff is the cessation of the service contract with Putnam County School District for janitorial services. This company is located at 1400 East Spring Street, Cookeville, TN 38506. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on November 19, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Upper Cumberland Local Workforce Development Area rapid response team, employed by UC LWDB/Mid-Cumberland HRA has been notified to coordinate services with the employer and affected employees. The Upper Cumberland Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
