American General Life Insurance Company has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective August 21, 2020, with all separations completed by November 30, 2020. The total number of affected workers is 79. This company is located at 340 Seven Springs Way, Brentwood, TN 37027. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on June 22, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce

Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
