ArcelorMittal USA LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective April 26, 2020. The total number of affected workers is 1. This company is located at 278 Franklin Rd., Brentwood, TN 37027. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 28, 2020.

The employees at the facility are not represented by a collective bargaining agreement.
