The total number of affected workers is 108. This company is located at 2526 12th Ave., South Nashville, TN 37204. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 2, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the Mid-Cumberland HRA

has been notified to coordinate services with the employer and affected employees.
