Brookdale Senior Living Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure which is effective starting April 6, 2020 with terminations continuing through April 20, 2020. The total number of affected workers is 58. This company is located at 7100 Commerce Way, Suite 175, Brentwood, Tennessee 37027. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on February 19, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the

Northern Middle Tennessee Development District has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
