Cox Automotive has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of what the company expects to be a temporary layoff which is effective on or about May 17, 2020. The total number of affected workers is 359. This company is located at 8400 Eastgate Blvd., Mount Juliet, TN 37122. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 8, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of
