Cummins Inc. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of permanent closure. Layoffs will begin on August 20, 2021, and continue through January 31, 2022. The total number of affected workers is 221. This company is located at 2680 Pershing Ave., Memphis, TN 38112. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on August 25, 2021.

The employees at the facility are represented by a collective bargaining agreement. The Greater Memphis Local Workforce Development Area rapid response team, employed by Workforce MidSouth, has been notified to coordinate services with the employer and affected employees. The Greater Memphis Local Workforce Development Board will be responsible for the oversight of the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
