Domtar Paper Company, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure which is effective October 8, 2020. The total number of affected workers is 308. This company is located at 100 Clinchfield Street, Kingsport, TN 37660. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on August 10, 2020.

The employees at the facility are represented by a collective bargaining agreement. The Northeast Local Workforce Development Area rapid response team, employed by the Alliance for Business and Training has been notified to coordinate services with the employer and affected employees. The Northeast Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
