Enterprise Holdings has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective March 23, 2020, or within 14 days of that date. The company indicates that these layoffs may result in employment loss, but is expected to be temporary. The total number of affected workers is 84. This company is located at 3655 Airways Blvd, Memphis, TN 38116. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 28, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Greater Memphis Local Workforce Development Area rapid response team, employed by Workforce Investment Network has been notified to coordinate services with the employer and affected employees. The Greater
