Goodman Manufacturing Company L.P. has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective March 8, 2020. The total number of affected workers is 11. This company is located at 1810 Wilson Parkway, Fayetteville, TN 37334. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on January 9, 2020.

The employees at the facility are represented by a collective bargaining agreement. The Southern Middle Local Workforce Development Area rapid response team, employed by the South Central Tennessee Development District has been notified to coordinate services with the employer and

affected employees. The Southern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
