HCFS Health Care Financial Services, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective April 14, 2020. The company has identified 32 positions that will be furloughed in addition to the 143 planned layoffs in a letter sent to the agency in a letter dated April 24, 2020. The total number of affected workers is 175, with 32 being new layoffs. This company is located at 3225 North Star Circle, Knoxville, TN 37777. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 27, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The East Local Workforce Development Area rapid response team, employed by the East TN HRA has been notified to

coordinate services with the employer and affected employees. The East Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
