HCFS Health Care Financial Services LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective April 14, 2020. Layoffs will begin on this date and will continue in stages ending June 1, 2020. The total number of affected workers is 220. This company is located at 3429 Regal Drive, Alcoa, TN 37701. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 14, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The East Local Workforce Development Area rapid response team, employed by the East Tennessee HRA has been notified to coordinate services with the employer and affected employees. The East Local Workforce
