Help at Home, LLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent closure which is effective March,31,

2021. The total number of affected workers is 107. This company is located at 7315 Clinton Highway, Suite B, Powell, TN 37849 and 1309 Tusculum Boulevard, Greeneville, TN 37745. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on January 29, 2021.

The employees at the facility are not represented by a collective bargaining agreement. The East Local Workforce Development Area's rapid response team, employed by the East TN HRA has been notified to coordinate services with the employer and affected employees. The East Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
