The Hertz Corporation has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective April 14, 2020, with all layoffs completed by April 20, 2020. The total number of affected workers is 79. This company is located at 1 Terminal Drive, Nashville, TN 37214. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on June 4, 2020.

A select number of the employees at the facility are represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and

affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
