Holiday Inn Express Downtown Nashville has filed a second official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective within 14 days of March 25, 2020, and May 1, 2020. The total number of affected workers is 8. This company is located at 920 Broadway, Nashville, TN 37203. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on May 26, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The

Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
