Loews Vanderbilt Hotel WARN # 202000200

Loews Vanderbilt Hotel has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff for 38 employees. Also, 111 employees whose temporary layoff is unexpectedly being extended, and who may not likely be able to be recalled before a 6 month period from the initial date of their temporary layoff. The effective layoff date is May 27, 2020. The total number of affected workers is 149. This company is located at 2100 West End Ave., Nashville, TN 37203. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on June 2, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce

Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
