Logistics Insight Corp. WARN # 202000015

Logistics Insight Corp., has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective April 1, 2020. The exact number of employees affected has not been determined, but is estimated at 96. The amount of work being transferred will determine the exact impact on the workforce. This company is located at 4500 Singer Road, Murfreesboro, Tennessee 37129. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on February 24, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the Mid-Cumberland Tennessee Development District has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
