The employees at the facilities are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the North TN Workforce Board, and the Upper Cumberland Local Workforce Development Area rapid response team, employed by the Upper Cumberland Development District, have been notified to coordinate services with the employer and affected employees. The Northern Middle and Upper Cumberland Local Workforce Development Boards will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
