NP 5th LLC dba AC/Residence Inn/Springhill Suites Downtown Nashville has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff which is effective August 28, 2020. The total number of affected workers is 72. This company is located at 410 5th Ave. S., Nashville, TN 37203. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on August 31, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area's rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the
