OMSNashville, PLLC has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff and a permanent layoff which is effective April 2, 2020. The total number of affected workers is 64. The number of affected workers temporarily laid off is 56. The number of affected workers permanently laid off is 8. This company is located at 131 Indian Lake Blvd., Ste. 100, Hendersonville, TN 37075. There are six other locations affected by this layoff. The six other locations are 307 Bluebird Dr., Goodlettsville, TN 37072, 355A Hancock St., Gallatin, TN 37066, 3130 Tom Austin Hwy, Ste. C, Springfield, TN 37172, 2200 21st Ave. South, Suite 101, Nashville, TN 37212, 2055 North Mt Juliet Rd, Suite 101, Mt Juliet, TN 37122, & 343 Franklin Road, Suite 210, Brentwood, TN 37027. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 15, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
