Primeritus Financial Services has filed a second official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff which is effective April 11, 2020. The total number of affected workers is 5. The company originally furloughed 148 employees on April 2, 2020. The company has since brought back 6 employees from the April 2, 2020 furlough and has furloughed 5 additional employees. This company is located at 435 Metroplex Dr., Nashville, TN 37211. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 9, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle
