Schulte Companies has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary layoff. It is the Company's hope that

global economy generally, and the Company's business operations specifically, these layoffs may be permanent. These layoffs will occur beginning March 16, 2020, through June 30, 2020. The total number of affected workers is 193 at two separate locations. These layoffs will occur at two company locations, 1111 Airport Center Drive, Nashville, TN, 37214, and 250 N Main Street, Memphis, TN 38103. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 1, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the Northern Middle Tennessee Workforce Board has been notified to coordinate services with the employer and affected employees at the Nashville location. The Greater Memphis Local Workforce Development Area rapid response team, employed by the Greater Memphis Workforce Board has been notified to coordinate services with the employer and affected employees at the Memphis location. The Northern Middle Local Workforce Development Board and the Greater Memphis Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
