TC Restaurant Group has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a temporary closure which is effective March 15, 2020. The total number of affected workers is 411. This company is headquartered at 301 Broadway, Nashville, TN 37201. The company operates 5 locations in the Downtown Nashville, TN area. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on March 30, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by the Mid-Cumberland HRA has been notified to coordinate services with the employer and affected

employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
