Marriott Hotel Services, Inc., dba Wildhorse Saloon has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a layoff. This layoff was initially intended to be temporary. The company now states, "it is reasonably foreseeable that these temporary actions may extend beyond six months." The layoffs began on March 21, 2020. This company is located at 120 2nd Avenue North, Nashville, TN 37214. The Number of affected employees is 123. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on June 10, 2020.

The employees at the facility are not represented by a collective bargaining agreement. The Northern Middle Local Workforce Development Area rapid response team, employed by Workforce

Essentials has been notified to coordinate services with the employer and affected employees. The Northern Middle Local Workforce Development Board will be responsible for the oversight of the continued follow up of Rapid Response and Dislocated Worker services associated with this event.
