Fayette County Public Schools has filed an official WARN Notice with the Tennessee Department of Labor and Workforce Development, notifying the agency of a permanent layoff effective June 30, 2026. The affected location is Fayette County Public Schools, located at 10425 Hwy 76 S., Somerville, TN 38068. The total number of affected workers is 75. The company notified the Tennessee Department of Labor and Workforce Development's Dislocated Worker Unit on April 30, 2026.

The employees at the facility are not represented by a collective bargaining agreement and do not have bumping rights. The Greater Memphis Local Workforce Development Area rapid response team, employed by the Greater Memphis Chamber, has been notified to coordinate services with the employer and affected employees. The Greater Memphis Local Workforce Development Board will be responsible for the oversight of and the continued follow-up of Rapid Response and Dislocated Worker services associated with this event.
